As per resolution dt.-11.01.2016 of the Vehicle Committee, District Judge's Court, Nadia, sealed tenders are invited from the intending owners/ concerned for hiring 7(seven) commercial non AC car in good and running condition like Swift D'zire, Indigo ECS or of similar model for official use of Judicial Officers posted at Sadar, subject to following terms and conditions as laid down in notification no.-3564-WT/3M-81/98 dt.-24.11.2008 of Transport Department, Govt. of West Bengal:-

1. The cars should be in new and running condition with all valid papers and documents i.e. Registration certificate, Insurance Policy, Tax token, blue book etc. in favour of the owners.
2. The fuel & mobil shall be supplied by the owner.
3. The drivers of the hired vehicle should be engaged by the owner.
4. The driver of the vehicle must have a valid driving license issued by appropriate authority.
5. The cost of maintenance, repairing, remuneration of the driver etc. shall be borne by the owner.
6. The vehicle shall be used during the court & office hours on all weekdays including Sundays and Holidays and if required at any time according to the direction of the undersigned.
7. The charge of consumption of fuel and the daily rate towards hiring charge of vehicle shall be paid by this office as specified by the latest order of the Transport Department of the Govt. of West Bengal and other financial rules subject to availability of fund.
8. The owner of the car will have to furnish a certificate of fitness of the car from the M.V authority, if tender is accepted.
9. The owner will have to replace a car of similar type for temporary period if the hired car fails to function for any reason with prior intimation to the undersigned.
10. The maximum rate of Rs. 490.00 per day will be allowed as hiring charge in view of notification no.-3564-WT/3M-81/98 dt.-24.11.2008 of Transport Department, Govt. of West Bengal.

The tender will be received upto 1.30 p.m on **25.01.2016** and the same will be opened on **27.01.2016** at 5.00 p.m.

The undersigned reserves the right to accept or reject any or all tenders without assigning any reason whatsoever.
