

- 4) Earnest Money to the tune of **Rs. 10,000/-** (Rupees Ten thousand) only is to be deposited through Bank Draft along with the tender papers in favour of the District Magistrate & District Election Officer, Nadia.
- 5) Warranty period must be mentioned in the challan of each above item.
- 6) Annual Maintenance contract should be made at the time of delivery of Projector Machine, Rate of AMC should be mentioned in the Tender paper.
