Tenderer himself or his authorized representative may remain present at the time of opening.

- 1) Non-refundable tender documents will be available from the Infrastructure Cell at Nazarath Section under Nadia Collectorate, Krishnagar on payment of Rs. 3,000.00 (Rupees three thousand) only by DCR and the tender document will be available on and from 15/02/2016 to 26.02.2016 upto 3.00 p.m.
- 2) The rate must include all taxes of State Government, Union Government (like PT, IT, VAT etc.) and the cost of carrying and all other incidental charges.
- 3) Self attested copies of Valid Profession Tax, I. Tax, VAT Registration, Trade Licence & Credential should be attached with the Tender Form not below a cumulative/total sum of Rs. 2.00 (Two lakh) within past three financial years on the same nature of work. This certificate should be issued by Head of the Office or D. D. O. of the establishment.
- 4) Any dislocation, delay, willful negligence will make this office compelled to forfeit the entire claim without assigning any reason whatsoever & initiate penal action against the defaulting tenderer/Agency as per rule.
