1. All the equipments required including man power for implementation of Live Monitoring of Sensitive Areas (LMSA) should be provided by Agency except vehicle.
2. Separate rate for each item should invariably & clearly be mentioned in the Letter Head Pad duly signed by the quotationer.
3. The rate offered by the quotationer should be included with all Taxes and duties.
4. Selected agency should have to stay on P-1day and P-day at the places for area in which LMSA should be monitored
5. The agencies should have to furnish an under taking regarding that they are willing to perform the work on a Non-judicial Stamp Paper.
6. Quotationer shall have to deposit earnest money of 40,000=00(Rupees forty thousand) only through Bank draft in favour of District Magistrate, Nadia .
7. The selected quotationer shall have to pay Rs. 50000=00(Rupees fifty thousand) security deposit in favour of the District Magistrate, Nadia through bank draft which will be released in favour of the depositor after successful completion of the wark.
8. The quotationer shall have to submit the following documents with the quotation
  - a) Upto date Sale Tax /Income / Vat clearance Certificate.
  - b) Trade licenses
  - c) Credential Certificate of performance of LMSA Work in previous Election.
