Sealed tenders are invited from the bonafide Contractor/Generator owners/Business person for supply of energy from Sound Less Green Diesel Generator as mentioned below for the period from 01.07.2016 to 30.06.2017 in the following terms and conditions:-

Terms and Condition

Generator lines will have to be connected in the offices of (1) Administrative Building(Except BCW, DYO, Agriculture, Income Tax, District Soldier Board, Civil Defence, RR&R Deptt, DCO, Spl. LAO, LR including Law Cell, Panchayat Deptt.) (2) Old Collectorate Building(exclusively Treasury Double Lock), Stamp Section, Record Room, Forms & Stationery, Election Go-down, Canteen & Ministerial Co-opt. (3) Sub-Divisional Officer's office .(4) Bunglow of District Magistrate (5) Addl. District Magistrate(General) Bunglow(6) Addl. District Magistrate(LR) Bunglow(7) Addl. District Magistrate(Dev.) Bunglow (8) S.D.O's(sadar) Bunglow, (9) Dist. Pool Car Section (10) Old Circuit House & (11) New Circuit House and also arrange for change over switches as and when required.

No charges other than hire charges mentioned in the Tender and approved by the District Magistrate, Nadia will be admissible at any situation whatsoever during the above mentioned period.

The tenderers are to furnish tender papers along with Sales Tax, Professional Tax, Electricity Duty Clearance certificate from the concerned authorities up to this month and a sum of Rs 10,000=00(Rupees ten thousand) only will have to be deposited by the tenderer as earnest money by bank Draft in favour of the District Magistrate , Nadia and the same will have to be submitted with the tender.

The tender should reach this office on or before 2.00 P.M. on ...30-06-2016 and the tenders will be opened at 2-30 P.M on that date, i.e 30-06-2016. The tenderer or his representative may remain present at the time of opening tender, if they so desire.

The load/power requirement shall be intimated to the successful tenderer.

Rate should be submitted inclusive of all charges (including lubricants/diesel/petrol/operator/hire charges etc.) and amount should be quoted both in figure and words.

The operator of generator should be available round the clock without any additional charges.

The wiring system including Change over switches etc. as may be required under the direction of Executive Engineer ,PWD(Electrical) should be installed and commissioned methodically at the nearest point of existing main and sub-main panel of the building which have been settled by P.W.D. Electric wing.

Bonafide Electrical Mechanic and License Holder Electrical Supervisor should be present and attend at least once in a day at all the premises to held checks as per requirement.

Electric License, Vat Registration Certificate, Pan Card, Trade License, Income Tax Clearance Certificate, Professional Tax, Electricity duty Clearance certificate up to current month from the concerned authorities should be submitted with the tender papers.

In case of engine failure, alternative arrangement for supply of power should be provided immediately by the agency without any additional payment from the authority.

Acceptance of the lowest rate is not obligatory and the District Magistrate, Nadia reserves the right acceptance or refusal of any rate without assigning any reason thereof.

The successful tendered will have to submit a Bank Draft of Rs. 10,000=00(Ten thousand) in favour the Collector, Nadia as Security Money and to install the Generator Set(s) at the given point(s) connect the point(s) as per direction of the Executive Engineer, PWD(Electrical) and start supplying power by the 15 days.....failing which the earnest money will be forfeited in favour of the Government without any communication. The tenderers will have to connect all the electric points of all the specifications positively and if desire, may examine the electric points prior to submission of the rates.

The District Magistrate, Nadia reserves the right to alter/modify/delete any or all the conditions specified above and add further terms and conditions as may be necessary.
