





Please refer to the letter under reference . Department of Telecommunications, Govt of India has informed this department that they are taking steps to identify the gaps in the domain of mobile connectivity and to develop projects geared to addressing the same and trying to obtain data on mobile coverage of the census villages. For this they have developed a portal (202.56.229.46/DoT/login.aspx) where the names and census code of the villages have been uploaded .BDOs can access the same with the help of unique password which DoT will send by email to the District Information Officer(DIO) of each district. The password will allow access to the villages falling within the jurisdiction of the block only.

BDOs will require to collect data with the help of Block / Panchayat functionaries in r/o service providers (BSNL/Airtel/Voda etc) whose services are available in the villages and enter them into the web portal.

Accordingly, I am directed to request you to advise/instruct BDOs to upload the status of connectivity of villages within 30.6.16 so as to enable Government of India/ State Government to ensure mobile connectivity in each and every parts of the country.





Dear Chief Secretary,

The Department of Telecommunications is committed to ensuring mobile phone connectivity in every part of the country. We have, therefore, initiated an exercise to identify the gaps in mobile connectivity and to develop projects geared to addressing the same.

2. As a first step in identifying the gaps, we have to obtain data on mobile coverage of the census villages in your State. The Department has developed a user friendly web portal with URL (202.56.229.46/DoT/login.aspx). The names and census codes of the villages have been uploaded on the portal. BDOs can access the portal with the help of a unique password which will be sent by email to the DIO (District Information Officer) of each district. The password will allow access to the villages falling within the jurisdiction of the Block only.
3. BDOs are required to collect data with the help of Block/Panchayat functionaries in respect of the service providers (BSNL, Airtel, Vodaphone etc.) whose services are available in the villages and enter them into the web portal. They simply need to select the village and tick the service providers from the menu containing the names of all service providers.
4. I would, therefore, request you to pass necessary instructions to District/Block functionaries to upload the status of connectivity of villages. Since this is an extremely simple exercise, I would request you to get the task completed by 30th June, 2016.
5. I look forward to your cooperation in this national task.
