b) Upto date clearance certificate of P.Tax, I.T.C.C. and S.T.C.C./VAT clearance.

Original copy of the above documents are required to be produced during submission of prayer for permission of purchase the tender for necessary verification.

Earnest money noted against the work @2% of the value of work will have to be deposited in the form of Bank Draft in favour of the undersigned. The earnest money will be converted into security money after acceptance. Balance 8% security money will be deducted from the bill to constitute 10% S.D. money. The security deposit money will be released as per norms.
