Notice inviting tender

Sealed tenders are hereby invited from intending agency/firms/bidders for cutting down & disposing/selling logs of 11(eleven) pc trees as mentioned below in ITEM-1-of CMOH, Nadia bungalow campus & only disposing/selling logs of 1(one) pc rubber tree of CMOH, Nadia office campus. The specification of the trees as described by the Divisional Forest Officer, Nadia-Murshidabad Division are as below:-

The sealed tenders are to be dropped into the dropbox of the CMOH Office, Nadia on or before 10/08/2016 at 12.00 noon positively and the same will be opened at 1.00 P.M. on the same day at the CMOH Office, Nadia. The bids for the tender will consist of two parts-1) Technical & 2) Financial. Each type of bid is to be kept in different sealed envelopes. The type of the bid e.g. 'technical' or 'financial' is to be superscribed on the concerned envelope. These two envelopes are to be kept in one sealed outer envelope. The Name & address of the bidder is to be superscribed on this outermost envelope. The bidder is to address the tender inviting authority i.e. Chief Medical Officer of Health, Nadia' & mention the Memo No. & NIT No. of this notice on this outermost envelope. The technical bid of the tender will accompany photocopy of trade license of allied service (the decision is however kept with the tender selection committee); Vat return filed within last 6(six) months from the date of opening of tender; PAN Card & IT return filed for F.Y.15-16/14-15, A.Y.16-17/15-16; Valid P.Tax registration certificate(valid for F.Y.16-17)/chllan deposited within last 6(six) months from the date of opening of tender. The bidder must maintain the following terms & conditions:-

i) The rate at financial bid should be quoted altogether for cutting & selling price of the 11(eleven) trees of ITEM-1 of CMOH, Nadia bungalow campus & selling price of logs of 1(one) pc rubber tree of CMOH, Nadia office campus. The rate will be quoted inclusive of all applicable charges and taxes.


(highest) rate quoted by the tenderer or bidder towards the cutting & selling price of the trees of ITEM-I (CMOH, Nadia bungalow campus) & selling price of logs of 1(one) pc rubber tree of CMOH, Nadia office campus will be accepted. The H1 rate must be higher than or equal to our reserved price evaluated by the Divisional Forest Officer, Nadia-Murshidabad Division.

iii) Earnest money @2% of total rate quoted at financial bid is to be submitted with the technical bid of the tender through demand draft drawn from any scheduled nationalized bank payable at Krishnagar, Nadia in favour of 'The Secretary, District Health & Family Welfare Samity, Nadia'.

iv). In case of successful bidder, the earnest money will be converted into the security money. After, issuing work order in favour of the successful bidder, he/she has to complete the whole procedure of cutting & disposing/selling within the time frame as mentioned in the work order. Security money may be retained upto the successful completion of the whole procedure of cutting & disposing/selling of the trees. The successful bidder may only transport the logs after obtaining Transit Pass from the Range Officer, Krishnagar Range.

v) The successful bidder should cut and fell trees and in the event of any damage of Government property during felling of trees or during extraction of lots must be compensated by the party itself. No claim for variation of quantity from schedule volume offered for sale will be entertained. The authority will not accept any liability for the defect or the deficiencies of any such timber offered for sale. The intending purchaser are requested to inspect the timber before the submission of quotation to make sure the quality and kind of timber they are bidding for. For inspection, they may contact the Administrative Officer, CMOH Office, Nadia (Mob: 9883076469) within office hours of workday.

The intending tenderer or one of his authorized representative (along with authorized letter) may remain present during the opening of tender to take note of the proceedings. The tender selection committee reserves the right to accept/reject any or all of the tenders without assigning any reason thereof.
