Financial Assistance:

For groups (SI no. ii & iii): Upto a maximum project cost of Rs.10 Lakhs for establishment of mini for purchase of machinery & equipments, chemicals & glass wares, Misc.

For individual (Sl no.i): Financial assistance upto 40 % of the project cost of 10 lakhs will be provided for establishment of mini STL. 80% of project cost will be provide for purchase of machinery & equipments, chemicals & glass wares, Misc. Laboratory articles and contingencies.

Funding Pattern: Subsidy will be shared under this scheme between Govt. of India and West Bengal in the ratio of 60:40.

Fund Flow Mechanism: INM Division will release grant – in – aid to state. The DLEC will receive funds from State Nodal Dept. for implementation of this programme. Similarly NCOF will release funds from NABARD under CISS. In case of credit requirement application may be forwarded by DLEC to lead bank for providing NABARD subsidy.

Training of Beneficiary: Training will be imparted on importance of soil testing in soil fertility management and related matter. Boarding & Lodging Charges, to & fro journey allowances, stipend & institutional charges will be provided to the beneficiary as per guidelines of the project.
