D. M(Gen.)/ A. D. M(Dev.) & A. D. M(L. R)'s Bungalow, DM's Pool Car Section, all rooms of Circuit House (both old & New), S. D. O. Sadar Office, Record Room, Forms & Stationery Sec., D. O. M. A. Section & R. T. C. at DOMA Building (approximately 150 lines) & (2) EPABX machine consisting of 10-12 lines at D. M's Bungalow Office which to be repaired and servicing the equipment/cable lines within reasonable time of receipt of communication from this end except supply of spares.

- 1) The Quotation Form will be available at Nezarath Section on and from 19/09/2016 to 27/09/2016 upto 04.00 p.m. on payment of Rs. 250.00 (Rupees two hundred fifty) only through D. C. R. on receipt of an application.
- 2) The Quotation form must be signed by the bidder with stamp/seal & the amount must be quoted both in words & figures.
- 3) Self attested copies of Valid Profession Tax, I. Tax, VAT Registration & Credential should be attached with the Tender Form.
- 4) The rate must include all taxes of State Government, Union Government (like PT, IT, ST) and the cost of carriage and all other incidental charges.
- 5) Once the amount quoted and submitted cannot be altered by any means or methods.
- 6) The Quotationer must quote the amount both in word & figure with his knowledge & belief after going through proper inspection.
