Online tenders item wise in two bid systems (Technical and Financial) are invited for supply of Spectacles with power Glass as per specification annexed for the year 2016-17. **The tender must be submitted online on the State Government e-tender portal <https://wbtenders.gov.in> before last date & time of submission of tender i.e. on 02/01/2017 at 5 pm.**

### 1) Procurement:

The Chief Medical Officer of Health, Nadia procures Spectacles with power Glass for approximately 10000 (ten thousand) number of Post-operative Cataract Patients/ School Eye Screening Student, near work to old person suffering from Presbyopia & the persons who have been operated for cataract surgery in Nadia district. The tender consists of four parts.

**Part A:** Supply of Spectacles with power Glass for Post operative Cataract Patients of Nadia district

**Part B:** Supply of Spectacles with power Glass for School Eye Screening Student of Nadia district

**Part C:** Supply of Spectacles with power Glass near work to old person suffering from Presbyopia of Nadia district

**Part D:** Supply of black goggles to the persons who have been operated for cataract surgery.

### 2. Terms and Conditions:

A tenderer may participate in all the parts (Part A, Part B, Part C & Part D) of the tender as per his/her discrimination.

The rates must be quoted with all taxes as per format.

The rates must be quoted for items including all applicable taxes and charges otherwise this will be cancelled. The rates quoted in respect of items shall not exceed the controlled price and or MRP fixed by GOI as below.

1. Spectacles with power Glass for Post operative Cataract Patients- **Rs.125/-spectacles**
2. Supply of Spectacles with power Glass for School Eye Screening Student-**Rs.275/ spectacles**
3. Spectacles with power Glass near work to old person suffering from Presbyopia-**Rs.100/- spectacles**
4. Black goggles – **Rs.25/- spectacles**

The Tenderer must submit online Technical bid and Financial Bid in **English/Bengali language**.

### 3. EMD:

An earnest money of **Rs.5000/-(five thousand ) only** for participation in tender for Spectacles with power Glass for Post operative Cataract Patients , **Rs.33000/-(thirty three thousand )** for participation in tender for Spectacles with power Glass for School Eye Screening Student , **Rs.4000/-( four thousand )** for participation in tender Spectacles with power Glass near work to old person suffering from Presbyopia & **Rs.2000/- (two thousand)** for black goggles is to be deposited separately by bank draft drawn from any scheduled nationalized bank in favour of 'The Secretary, District Health & Family Welfare Samity, Nadia' payable at Krishnagar, Nadia .

The scanned copy of the earnest money deposit (EMD) must be uploaded online i.e. in [www.wbtenders.gov.in](http://www.wbtenders.gov.in) in the statutory cover of the technical proposed as per G.O no- 1592-F(Y) dt 26/3/14 of the Principal Secretary to the Govt. of WB, Finance Department, Audit Branch. However, after finalization of the tender process, the successful bidder must submit the EMD in original to this office on demand within specified time period before issuing letter of acceptance to him.

#### **Security Money:**

After issuance of letter of acceptance a Security money of **Rs.12,500/-(twelve thousand five hundred) only** for Spectacles with power Glass for Postoperative Cataract Patients , **Rs.82,500/-(eighty two thousand five hundred )** for Spectacles with power Glass for School Eye Screening Student, **Rs.10000/-( ten thousand )** for Spectacles with power Glass near work to old person suffering from Presbyopia & **Rs.5000/- (five thousand)** for black goggles for the persons who has been operated for cataract surgery is to be deposited by successful bidders for concerned items in the form of a demand draft drawn from any scheduled nationalized bank in favour of 'The Secretary, District Health & Family Welfare Samity, Nadia' payable at Krishnagar, Nadia within the specified time period mentioned in the letter of acceptance. Non submission of security money will lead to forfeiture of earnest money of the concerned bidder. Security Money may be retained up to one year from the acceptance of tender. Supply/procurement order will be issued to the concerned bidder only after successful deposition of performance security by the concerned bidder.
