

Sealed tenders are invited from the working contractors of Backward Classes Welfare, Nadia as well as from bonafied contractors/working contractors of Engineering Department of Govt. of West Bengal / Govt. of India i.e., Public Works Department, Rail, CPWD, Zilla Parishad, Nadia, Panchayat Samities of Nadia District etc. for execution of work according to enclosed list.

**Terms and Conditions :-**

1. Tender will be received in prescribed Form upto **2.00 p.m. on 21/07/2020** at the office of the **Disatrick Welfare Officer, B.C.W., Nadia** and will be opened on the same day **at 5 PM i.e. on 21/07/2020** in the office chamber of the undersigned in presence of the participating tenders who will be present at that time. If the said day is declared as a holiday, tender will be received and opened on the next working day as per same time schedule and other conditions will remaining unchanged.
2. Particulars of work with schedule of items, plans, specification etc. may be seen in the office of the **District welfare Officer, B.C.W., Nadia** during office hours on any working day.
3. Application for the job will be received upto **5.00 p.m. on 17/07/2020** and tender paper will be issued upto **4.00 p.m. on 20/07/2020** to the contractors/Agencies on production of **Demand Draft in the name of "District Welfare Officer, BCW, Nadia" payable at Nadia of Rs. 750/- (Seven Hundred Fifty) only. Valid upto date Income Tax clearance certificate, PAN, upto date Trade license, upto date P. Tax clearance certificate, GST No.** should be submitted and if necessary current Bank A/C may also to be produced on demand.
4. Intending Tenders for obtaining Tender Papers shall have to submit applications, Stating Name of work and work serial for which he applied for in printed letter head. If the contractor purchased the tender paper and not dropped the same will not entitled to get tender paper in next N.I.T.
5. Intending Tenderer will have to submit Credential Certificate and work order of similar nature of work at least 50% of the work value for last 5 years with the application. No tender paper will be issued to any contractor who does not satisfy the above conditions and they have to produce all original papers/documents at the time of purchase of the Tender papers.
6. Earnest Money @2.0% for each job to be deposited by Demand Draft on Estimated Cost of the Scheme along with duly filled in Tender paper and should be submitted in a sealed cover. The name of the schemes and serial no. should be clearly written on top of the sealed cover.

7. Tenderer must satisfy themselves before submission of their tender by careful inspection of the work site regarding probable difficulties which may have to be faced during actual execution. No extra claim will be entertained for completion of the work within the scheduled time which will be the essential part of the contract. In case of failure, the contractor shall have to make good damage and be accused for delay as charges by the undersigned and his earnest money and security money are liable to be forfeited and enlistment be cancelled.
8. All working tools and plants are to be arranged and supplied by the tenderer. No materials will be supplied by the department i.e. Cement, M.S. Rod, Tor steel, wooden shutter and frame etc.
9. The work shall be executed strictly in accordance with the vetted plan and specification of the job and under technical supervision of Engineering Cell, BCW Nadia. Only quality materials as specified in the estimate shall be used in the construction. In case the work under execution or on completion is found to be of poor standard or of below the specification as laid down in the plan and schedule of estimate the undersigned will be at liberty to withhold payment and cancel the contact or take any other action as found proper to compensating the defects.
10. The Security Deposit @ 8.0% (eight) percent of the billed amount will be deducted from R/A and final bill. Income Tax, GST, Labour Cess and other statutory tax of the Government will be deducted from bill accordingly. An agreement on non-judicial stamp paper in prescribed form will be done within the stipulated time.
11. The Authority reserves the right to accept / reject the tender without assigning any reason whatsoever.
