So, the tender selection committee unanimously decides to consider 1) Adwell International Pvt Ltd, 2) Aparna Trading Corporation, 3) Associated Letter Press, 4) Calcutta Art Studio Private Ltd., 5) Kalpana Offset Pvt Ltd., 6) MD Enterprise, 7) MS Printernet, 8) PBD Enterprise, 9) Printospet 10) M.D Enterprise (2) and 11) S Mitra & Co. as technically eligible. So, financial bid of these 11 (Eleven) bidders will be opened.

So, the financial bid of these 11 bidders will be opened on 01/03/2021 at 03:00 A.M./P.M. at CMOH Office, Nadia.


