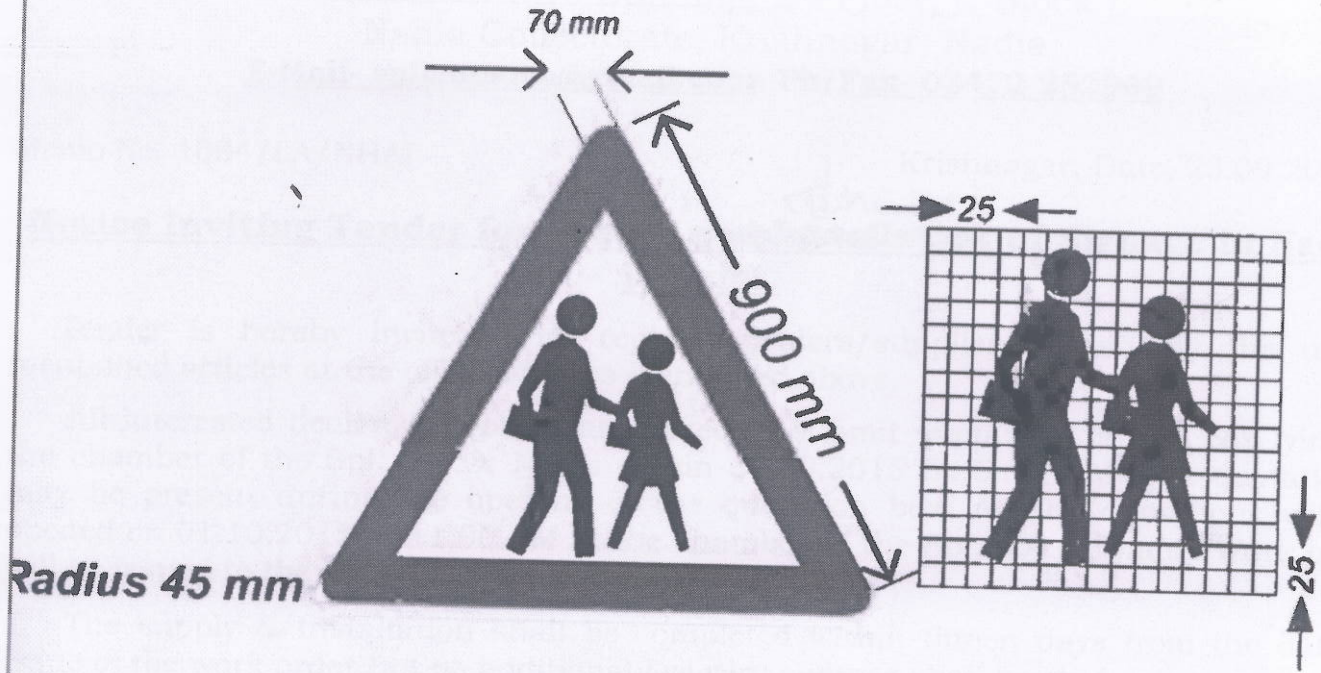


Fig. 15.34 School Ahead

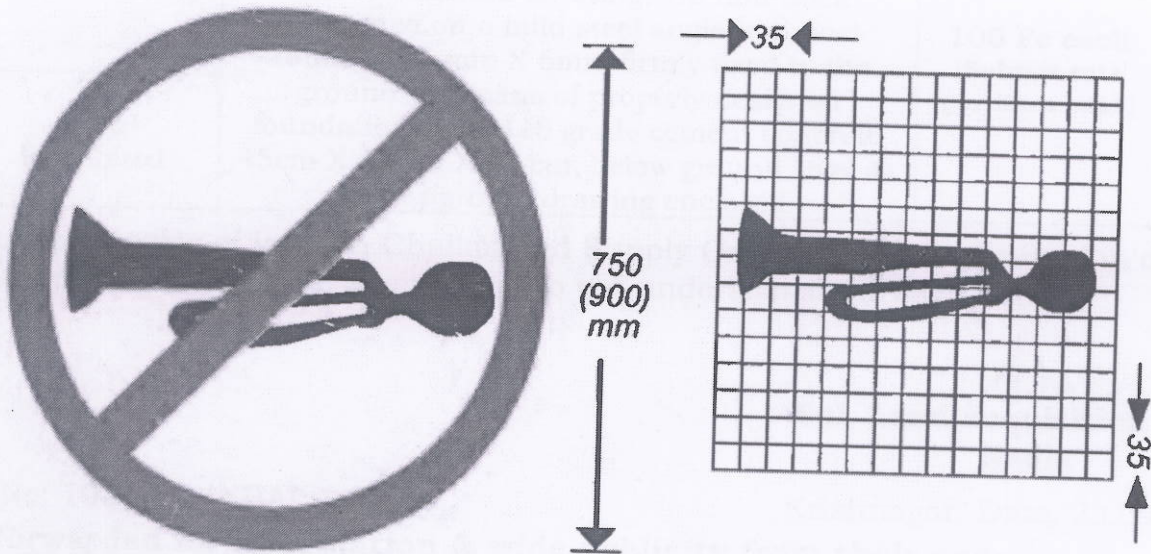


Fig.14.18 Horn Prohibited
