Sealed tenders are hereby invited from the bonafied Nurserymen/Agencies/Contractors for supply of 6,000 nos (Six thousand) good quality at least one year old mango seedlings (desirable for grafting ongoing season 2021-2022) in good quality poly packets (size 8"X 8") and subsequent maintenance for 6(six) months. Interested tenderers can offer rate observing the following terms and conditions strictly.

Terms and conditions

1. Superscribe the sealed envelope containing tender as "Supply of Mango Seedlings in poly packetsand subsequent grafting on the same plant"addressed to the Assistant Director of Horticulture, Krishnagar, State Horticultural Research and Development Station, Krishnagar, Nadia with an open demand draft of Rs20, 000/-(Rupees twenty thousand) only as security deposit in favour of the Assistant Director of Horticulture, State Horticultural Research and Development Station, Krishnagar, Nadia in any nationalized bank payable at Krishnagar.

2. The tenderers may apply in the specified application format available from the office of the **Assistant Director of Horticulture**, State Horticultural Research & Development Station, Krishnagar, Nadia from the date of issue of the notice at working days from 11.00 am to 3.00 pm. up to 12.00 noon of 15.09.2021and also in the Website(www.nadia.nic.in)

3. The Maximum offered price for each successful mango seedling will not exceed the Govt Rate i.e. 15.00 (Rupees Twelve only) including service charges.

4. Rate should be quoted per seedling basis both in figure and words including the cumulative cost of seedling with poly packet & labour, making nursery beds, carrying it and placing in the desired place in the field and maintenance of the total nursery with modern nursery management practices, cutting of the wild growth, manuring, weeding, spraying ,irrigation discarding the unhealthy, dead and unsuccessful seedlings and maintenance of healthy ones for six months.

5. The maintenance of the nursery of grafted plants such as weeding, manuring & fertilizer application, spraying of plant protection chemicals etc, irrigation, discarding the unhealthy, dead and unsuccessful plants and maintenance of healthy ones up to 15st March, 2021. If the nursery is not maintained properly by the successful tenderer, this Research Station will maintain the nursery without giving intimation to the successful tenderer. In this case, the undersigned reserves the right to deduct a percentage (upto 50%) of the final payment and the security deposit will be forfeited also.

6. Nursery bed must be prepared by the tenderer with modern nursery techniques i.e. making of tranches (hapa) must be covered by polythene sheet to protect weed infestation and save irrigation water, layout and making of nursery bed including tractor/power tiller, cleaning of surroundings to protect from pest infestation, use of root trainer before packeting of layered plants, use of shade net for faster growth of nursery plants in good quality packet (8"x8") etc. Otherwise, the Undersigned reserves the right to deduct up to 25% of the total bill amount and the security deposit will be forfeited.

7. Mother plants of Amrapali variety of Mango of State Horticultural Research and Development Station, Krishnagar must be utilized as the source of scion sticks under strict supervision of Authority. In any situation, no scion sticks from Nursery beds of this station and from outside sources will be allowed. If it happens then the undersigned reserves the right to cancel such type of grafted plants during counting and the work order will be cancelled. Grafting activities will be done only on working days under strict supervision of appropriate authority of this station.

8. Tenderers must have experience in propagation works in any Govt. farms / places and have to submit the credential certificate in this regard except Nurserymen who must who must submit the nursery registration documents.

9. Tender without the requisite security deposit will stand invalid and summarily be cancelled.

10. The security money of the successful tenderer will only be retained and the same will be returned back after satisfactorily completion of the tender period. The security deposit will be forfeited if any damage to the Govt. property is caused by the successful tenderer during the tender period/ if less than 90% of the total seedlings as mentioned in the work order are supplied.

11. In case the successful tenderer does not start the work within 7(seven) days from the date of issue of the work order the

security deposit of the tenderer will be forfeited and his work order will be cancelled.

12. The ongoing works in the farm campus may be visited on any working day under the guidance of Authority of State Horticultural Research and Development Station, Krishnagar, Nadia.

13. The Authority will bear no responsibility for any damage caused due to any natural calamity, theft, stray cattle etc.

14. Payment will be made after possessing of satisfactory certificate from appropriate authority of State Horticultural Research and Development Station, Krishnagar, Nadia.
