2. All the materials put up for sale through auction will be on "As is where is basis" and "No Complaint Basis". The Sub-Divisional Officer reserve the right to accept / reject any offer /bid without specifying any reason thereof. All quantities are only estimates and without guarantee.
3. Rates must be furnished for all trees (as per Annexure-I) only. No partial rate will be entertained.
4. The auctioneers shall quote their bids in prescribed format both in figures & words and submit bids in



sealed envelopes and shall be addressed to the Sub – Divisional Officer, Ranaghat, Nadia. With reference of the Auction Notice . Bid quoted/written in other than the specified space liable to cancellation

**5. INSPECTION OF MATERIALS** : Inspection will be allowed by the Principle with prior appointment from the principle. Inspection will be limited to visual checking only. Any clarification require may be sought by the bidders at the time of inspection and no dispute regarding or its physical conditions / location will be entertained thereafter.

**6. VALIDITY OF BIDS** : All Bids will be valid for acceptance by the Sub-Divisional Officer, Ranaghat for a period of 15 (Fifteen) days from the date of closing of auction, excluding the date of closing. In case the 15<sup>th</sup> day falls on a holiday or remain closed for Office of the Sub-Divisional Officer, Ranaghat, Nadia. Such Bids will be deemed to be automatically extended to be valid upto next working day.

**6.1.** Upto the validity period of the Delivery Order/ Release Order issued by PRINCIPLE or upto the extended period of validity of the Delivery Order / Release Order in case of Delivery Period is extended by the PRINCIPLE as his sole discretion as the case may be.

**7. SALE INFORMATION** :The status of highest bids having been accepted on Confirmed or STA (Subject to Approval) basis must be personally seen by the Bidders after closing of auction which will be displayed upto 7 (Seven) days from the date of closing of auction (including the date of closing of auction) and payment of Post-Bid EMD / SD must be made accordingly. Although immediately after closing of Auction a Sale Intimation Letter will be issued by mail/ e-mail to the Highest Bidder, advising him to deposit the prescribed Security Deposit within the stipulated time.
